- Agency having experience of working with Central Govt/State Govt./PSUs shall be given preference. (Copy of the work-orders to be included in the technical proposal).
- Agency must have an average turnover of Rs 75 Lacs in the last 3 financial years ending March' 2024, from similar nature of work. Proof to be submitted. (Copy of the CA certificate with UDIN no. to be provided)
